

*Excerpt from the Tariff on fees collected by state health control authorities and national centers for public health issues under the Health Act (promulgated in SG, issue No.83 of 16 October 2007, amended SG, issue 39 of 25 May 2010, amended SG, issue 101 of 28 December 2010, amended SG, issue 5 of 14 January 2011, amended SG, issue 16 of 22 February 2011, amended SG, issue 38 of 17 May 2011, amended SG, issue 1 of 3 January 2012, amended and supplemented SG, issue 81 of 23 October 2012, amended and supplemented SG, issue 17 of 23 February 2018 ), applicable to the Republic of Bulgaria for granting of an authorization for making available on the market of biocidal products*

"Art. 3. (Am. - SG, issue 101 of 2010, effective of 28.12.2010, amended SG, issue 17 of 2018) (1) The following fees are collected for granting of an authorization for making available on the market of biocidal products:

1. for granting of a national authorization for making available on the market of a biocidal product or a group of biocidal products under Art. 17a of the Protection against the Harmful Impact of Chemical Substances and Preparations Act (PAHACSP) - BGN 8450 for a single biocidal product and BGN 13 500 for a group of biocidal products;

2. for granting of a national authorization for making available on the market of a biocidal product or a group of biocidal products under the simplified procedure under Art. 17b of PAHACSP –BGN 2150 for a single biocidal product and BGN 3440 for a group of biocidal products;

3. for granting of an authorization for making available on the market of a biocidal product or a group of biocidal products by mutual recognition in sequence under Art. 17d of PAHACSP – BGN 2850 for a single biocidal product and BGN 4560 for a group of biocidal products;

4. for granting of an authorization for making available on the market of a biocidal product or a group of biocidal products by mutual recognition in parallel under Art. 17e, par. 1 of PAHACSP, in the cases when the Republic of Bulgaria is a reference Member State – BGN 8450 for a single biocidal product and BGN 13 500 for a group of biocidal products;

5. for granting of an authorization for making available on the market of a biocidal product or a group of biocidal products by mutual recognition in parallel under Art. 17e, par. 3 of PAHACSP, in the cases when the Republic of Bulgaria is a reference Member State - BGN 2850 for a single biocidal product and BGN 4560 for a group of biocidal products;

6. for granting of an authorization for making available on the market of a biocidal product or a group of biocidal products, authorized in another Member State by mutual recognition under Art. 17f of PAHACSP – BGN 2850 for a single biocidal product and BGN 4560 for a group of biocidal products;

7. for granting of a provisional authorization for making available on the market of a biocidal product or a group of biocidal products under Art. 17n of PAHACSP - BGN 8450 for a single biocidal product and BGN 13 500 for a group of biocidal products;

8. for granting of an authorization for making available on the market of identical biocidal product under Art. 17i of PAHACSP – BGN 525;

9. for granting of an authorization for a parallel trade of a biocidal product under Art. 17k of PAHACSP – BGN 340.

(2) The following fees are collected for amendment of a national authorization for making available on the market of a biocidal product under Art. 17a of PAHACSP:

1. for administrative changes within the meaning of Art. 3, par. 1, letter "aa" of Regulation (EU) No 528/2012 of the European Parliament and of the Council of 22 May 2012 concerning the making available on the market and use of biocidal products (OJ, L 167/1 of 27 June 2012) (Regulation (EC) No528/2012) - 70 BGN;

2. for minor changes within the meaning of Art. 3, par. 1, letter "ab" of Regulation (EC) No528/2012- BGN 320;

3. for major changes within the meaning of Art. 3, par. 1, letter "ac" of Regulation (EC) No528/2012 – BGN 1030

(3) A fee to the amount of BGN 4050 is collected for the renewal of a national authorization for making available on the market of a biocidal product or a group of biocidal products under Art. 17c of PAHACSP.

(4) A fee to the amount of 70 BGN is collected for amending of an authorization for making available on the market of a biocidal product or a group of biocidal products by mutual recognition in sequence or mutual recognition in parallel under Art. 17d and Art. 17e of PAHACSP.

(5) The following fees are collected for the renewal of an authorization for making available on the market of a biocidal product or a group of biocidal products by mutual recognition in sequence or mutual recognition in parallel under Art 17d and Art. 17e PAHACSP:

1. when the Republic of Bulgaria is elected as reference Member State – BGN 7200;

2. when the Republic of Bulgaria is elected as Member State concerned – BGN 1200.

(6) For issuance of an authorization for making available on the market of a biocidal product or a group of biocidal products under Art. 18 of PAHACSP, a fee of BGN 920 for a single biocidal product and BGN 1470 for a group of biocidal products is collected.

(7) The following fees are collected for amendment of authorization for making available on the market of a biocidal product or a group of biocidal products under Art. 18 of PAHACSP:

1. for administrative changes within the meaning of Art. 3, paragraph 1, letter "aa" of Regulation (EC) No528/2012 and for amendment related to the fulfillment of the requirement of § 33 of the Final and Transitional Provisions of the Amendment and Supplement Act to the Protection Against the Harmful Impact of Chemical Substances and Preparations Act (SG, issue 102/2015) - BGN 50;

2. for minor changes within the meaning of Art. 3, par. 1, letter "ab" of Regulation (EC) No528/2012 – BGN 150;

3. for major changes within the meaning of Art. 3, par. 1, letter "ac" of Regulation (EC) No528/2012 – BGN 350

(8) A fee of BGN 1890 is collected for issuance of an authorization under Art. 30, par. 5 of PAHACSP."
